1.1.i. Ordinance No. 913

An Ordinance of the Common Council of the Mayor and Common Council of Westminster, a Municipal Corporation of the State of Maryland (The "Issuer"), Providing for the Issuance and Sale of an Aggregate Principal Amount Not To Exceed Sixteen Million Five Hundred Thousand Dollars (\$16,500,000) of Bonds of the Issuer, To Be Known As "The Mayor And Common Council Of Westminster Taxable Infrastructure Bonds, 2019 Series A" (Or By Such Other or Additional Designation or Designations as Required by the Community Development Administration Identified Herein) (The "Bonds"), to be Issued and Sold Pursuant to the Authority of Sections 4-101 Through 4-255 of the Housing and Community Development Article of the Annotated Code of Maryland, as Amended, and Section 19-207 of the Local Government Article of the Annotated Code of Maryland, as Amended, for the Purpose of (I) Refunding in Whole or in Part the Outstanding (A) The Mayor And Common Council of Westminster Taxable General Obligation Bond, Series 2015a and/or (B) The Mayor and Common Council of Westminster Taxable General Obligation Bond, Series 2015b, and Thereby Refinancing All or a Portion of the Costs of the Project Referred to by the Issuer as the "Broadband Fiber Infrastructure Project" Previously Financed or Reimbursed From Proceeds of Such Prior Bonds, (ii) Funding a Portion of a Capital Reserve Fund and/or Other Reserves, and/or (iii) Paying Issuance and Other Costs Related to the Bonds; Providing That the Bonds Shall be Issued Upon the Full Faith and Credit of the Issuer; Providing for the Disbursement of the Proceeds of the Sale of the Bonds and for the Levy of Annual Taxes Upon All Assessable Property Within the Corporate Limits of the Issuer for the Payment of the Principal of and Interest on the Bonds as They Shall Respectively Come Due; Providing for the Form, Tenor, Denominations, Maturity Date or Dates and Other Provisions of the Bonds; Providing for the Sale of the Bonds; and Providing for Related Purposes, including, Without Limitation, the Method of Fixing the Interest Rate or Rates to be Borne by the Bonds, and the Approval, Execution and Delivery of Documents, Agreements, Certificates and Instruments; and Generally Relating to the Refunding of Such Prior Bonds
